The goods and services shown below are those we can provide for our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR & STAFF AND OVERHEAD:

Our services include conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

SERVICES OF FUNERAL HOME AND STAFF

PROFESSIONAL SERVICES:

Basic Services of Funeral Director & Staff and Overhead:.....\$2085.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.

Embalming:.....\$300.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. * Omega offers green embalming chemicals upon request. Restorative will be additional per quote.

Forwarding Remains to another Funeral Home: \$ 2035.00

This charge includes minimum services of funeral director and staff, transfer of remains to funeral home, embalming, if required, transfer of remains to common carrier, combination unit, Oregon State filing fee. This fee does not include viewing or dressing of remains, certified copies of death certificates, or common carrier fees, special care of autopsy remains or special items that may be requested.

Receiving Remains from another Funeral Home: \$ 1375.00

This charge includes minimum services of funeral director and staff, transfer of remains from common carrier to funeral home, transfer of remains to cemetery (25 mile radius; utility vehicle). This fee does not include viewing or graveside service, memorial book or memorial folders.

Direct Cremation: \$ 1175.00 to \$5020.00

This charge includes minimum services of funeral director and staff, transfer of remains to funeral home, traditional cremation process, and cardboard container for the cremated remains.

A direct cremation is disposition of human remains by traditional cremation without formal viewing, visitation or ceremony with the body present.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard. The purchaser may provide their own alternative container or casket.

BURIAL OPTIONS:

Immediate Burial:\$1560.00 to \$ 5970.00

This charge includes minimum services of funeral director and staff, transfer of remains to funeral home, transport of casketed remains to cemetery (within 25 mile radius in a utility vehicle) and a Minimum (Laminated MDF with blue cover) casket. This fee does not include preparation of the remains, dressing of remains, use of facilities for viewing, or filing fee. This fee does not include a graveside service or gathering of any kind.

An immediate burial is disposition of human remains by burial without formal viewing, visitation or ceremony with the body present except for a graveside service.
